I am writing to thank you for the excellent job PMBR did in preparing me for the MBE. I am a 1995 graduate of William Mitchell College of Law who took the three day PMBR Multistate Workshop and Bar/Bri for the July 1995 Minnesota Bar Exam.

My recently received Multistate score of 176 was a very nice surprise! This placed me in the 99th percentile in Minnesota. I can only attribute this to PMBR. As I was working full time, I needed the wealth of information and tips contained in those three days.

The Bar/Bri course provided a good review for the essay portion of the exam. However, it did almost nothing to prepare me for the Multistate. The PMBR workshop is essential to preparing for the MBE. Dear Professor Feinberg:


I attended the three-day PMBR workshop in Minneapolis, MN in July, 1995 and am fully convinced that my passing the Minnesota Bar with an MBE score of 171 in July 1995 is due to the PMBR course. As the lecturer promised, there was more substantive information in those three days than in the Bar/Bri course which I faithfully attended. Having had little practice with, and considerable fear of, multiple choice tests in general, I am especially proud of my MBE score.

Not only is PMBR essential for a good score on the MBE portion of the Bar, I think that it is invaluable for the essay portion as well. One of the eight Minnesota essays was a products liability question which I answered confidently directly from the PMBR course. Only the PMBR course actually prepared me to write that essay; therefore, before I even got to the MBE portion of the Minnesota Bar, I knew that my PMBR course had paid for itself.

Finally the PMBR lecturer gave an array of useful information on practical aspects of taking and passing the Bar exam which definitely made the whole experience more tolerable.

In sum, I wholeheartedly urge Minnesota students to take PMBR to be fully prepared and not to be satisfied just with Bar/Bri.
